# END POINT ASSESSMENT (EPA) REQUIREMENTS

## KNOWLEDGE ASSESSMENT

A final test to evaluate the skills and knowledge attained during the course

- The test will comprise 40 questions over 4 themes.
- The test should typically take 90 minutes to complete with an additional 60 minutes available for preparation, research and reflection time.
- The knowledge test will be a combination of multiple-choice questions and calculation-based questions.
- The knowledge test will be completed remotely at a suitable venue.
- Overall result of test is graded as fail, pass or distinction.

## PROFESSIONAL DISCUSSION UNDERPINNED BY A PORTFOLIO

- The portfolio of evidence will be completed on-programme and must reflect the full range of knowledge, skills and behaviours detailed in the standard
- The portfolio should contain evidence collated from the workplace such as, but not limited to, workplace product evidence, spreadsheets, working papers, email communications, meeting minutes, timesheets, screenshots of accounting dashboards and data analytics, appraisal and 1-2-1 objective setting, worksheets, assignment projects and reports, record of any formal discussions.
- Evidence submitted can address more than one of the knowledge, skills, and behaviours of the standard – holistic evidence
- The professional discussion will be conducted by the independent assessor, you will be asked at least 10 questions to demonstration competence.
- The discussion will take place under exam conditions
- The duration of the professional discussion will be a minimum of 60 minutes
